Subject: Release of central funds for payment of TA/Stipend to the trainees sponsored by the State under 'Technical Assistance' component of the Centrally Sponsored Scheme of 'Establishment of new Industrial Training Institutes (ITI s) in North Eastern States and Sikkim' – Release of funds to the **State of Arunachal Pradesh**.

Sir,

I am directed to convey the sanction of the President for release of central assistance of Rs. 1,19,088/- (Rupees One Lakh Nineteen Thousand Eighty Eight only) to the State of Arunachal Pradesh for payment of TA / stipend to a trainee, who is sponsored by the State Government and is undergoing training in DGET field institute under the Technical Assistance component of the Centrally Sponsored Scheme 'Establishment of Industrial Training Institutes (ITI s) in North Eastern States and Sikkim'.

2. The release of central fund of Rs. 1,19,088/- in respect of the said scheme, is subject to the following conditions:

- (i) The amount sanctioned is towards the payment of one time to and fro fare by Sleeper II Class and / or bus fare, as applicable and towards the payment of stipend @ Rs. 500/- per month per trainee for either the course duration or the period of one year, whichever is of shorter duration.
- (ii). The grant shall be utilized only for the purpose for which it has been sanctioned and no portion of it shall be spent on any other item.
- (iii). The Utilisation Certificate in Form GFR 19-A indicating details of expenditure under the scheme should be furnished to the Directorate General in Duplicate.
- (iv). The amount sanctioned should be utilized within a period of one year from the date of issue of the sanction and any amount not spent by that time should be surrendered to the Central Government.

3. The sanction relates to Plan Expenditure and is in accordance with the pattern of assistance approved by the Planning Commission and Ministry of Finance.

4. The expenditure is debit to the Major Head "3601" during FY 2006-2007–
