Notification

S.O. 88 (E). Whereas, by a notification of the Government of India in the Ministry of Labour and Employment number S.O.162(E), dated the 7th February, 2006, the Central Government constituted the Central Advisory Committee for a period of three years with effect from 19th February, 2006 and the term of the said Committee has since expired on 18th February, 2009;

And whereas, the Central Government is of the view that such a Committee must be reconstituted;

Now, therefore, in exercise of the powers conferred by section 6 of the Iron Ore Mines, Manganese Ore Mines and Chrome Ore Mines Labour Welfare Fund Act, 1976 (61 of 1976) (hereinafter referred to as the said Act) read with sub-rule (1) of rule 3, clause (a) of sub-rule (1) of rule 4 and rule 16 of the Iron Ore Mines, Manganese Ore Mines and Chrome Ore Mines Labour Welfare Fund Rules, 1978, and in supersession of the notification of the Government of India in the Ministry of Labour and Employment number S.O.162(E), dated the 7th February, 2006, except as respects things done or omitted to be done before such supersession, the Central Government hereby constitutes the Central Advisory Committee and appoints the following persons to the said Committee to co-ordinate the work of the Advisory Committees constituted under section 5 of the said Act and to advise the Central Government on the matters arising out of the administration of the said Act, for a period of three years from the date of publication of this notification in the Official Gazette, namely:-
