
As you are aware, the Government of India is implementing a National Child Labour Project (NCLP) Scheme since 1988 for the educational rehabilitation of children withdrawn from certain identified occupations and processes. Under the Scheme, Special Training Centres are being operated wherein these children are provided with bridge education, vocational training, stipend, mid-day-meal, health check-up etc for a maximum period of three years before being mainstreamed into formal education system. The Scheme is presently sanctioned in 270 districts in the country (List of NCLP Districts in your State enclosed). At present 115 Districts are operational out of 270 Districts due to mainstreaming of children into formal educational system.

As per the extant NCLP Guidelines, a survey is to be conducted twice in a plan period in the project area to determine the target group. The survey is to be conducted under the Chairpersonship of Collector/District Magistrate and to comprise of officers of other relevant departments such as Labour, Education, Women & Child Development, Health and also to the civil society organizations.

You are, therefore, requested to assess the presence of child labour in all the NCLP districts in your State through survey as per existing guidelines of NCLP, to identify the working children in the districts where survey has not been done for the last three years and may intimate the same to the Ministry at the earliest. Fund would be released based on the requirement/assessment as submitted by Districts.
