G.S.R... - In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Vocational Rehabilitation Centers (Group 'B') Recruitment Rules, 1996, except as respects, things done or omitted to be done before such supersession, the President of India hereby makes the following rules regulating the method of recruitment to the posts of Rehabilitation Officer, Psychologist, Career Coach (Rehabilitation Counselor), Vocational Instructor, Office Superintendent and Store Keeper of group 'B' cadre (Gazetted and Non-Gazetted) in the offices of National Career Service Centre for Differently Abled (Erstwhile Vocational Rehabilitation Centers) under the Directorate General of Employment, Ministry of Labour and Employment, namely:-

1. **Short title and commencement – (1)** These rules may be called the National Career Service Centre for Differently Abled (Group 'B', Gazetted and Non-Gazetted posts) Recruitment Rules, 2020.  
  
(2) They shall come into force on the date of their publication in the Official Gazette.
2. **Number of the posts, classification and Level in the Pay Matrix** - The number of the said posts, their classification and the Level in the Pay Matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
3. **Method of recruitment, age limits, qualifications, etc.** - The method of recruitment, age limit, qualification and other matters relating thereto shall be as specified in columns (5) to (13) of the said Schedule.
4. **Disqualification** - No person,-
  - (a) who has entered into or contracted a marriage with person having spouse living; or
  - (b) who, having a spouse living, has entered into or contracted a marriage with any person,shall be eligible for appointment to the said posts:  
  
Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.
5. **Power to relax** - Where the Central Government is of the opinion that it is necessary or expedient so to do, it may order and for reasons to be recorded in writing relax any of the provision of these rules with respect to any class or category of persons.
6. **Saving** - Noting in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for candidates belonging to the Schedule Castes, the Scheduled Tribes, the Other Backward Classes, the Ex- Servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
