Dear Shri Sanwariyaji,

The Ministry of Labour and Employment is administering a Grant-in-aid scheme under which financial assistance is provided to Non- Governmental Organisations (NGOs)/Voluntary Organisations (VOs) for undertaking awareness campaigns for the benefit of women labour. In case of new projects, an inspection of the organisation is conducted by the concerned RLC(C) to verify their credentials/financial standing, etc. and before releasing 2<sup>nd</sup> and final instalment of Grant-in-aid to the organisation, concerned Regional Labour Commissioner (C) is required to furnish specific inspection report in requisite proforma as to whether the organization has completed/conducted successfully the said project, to the Ministry.

2. The required inspection Reports of 41(forty one) organisations (as per list enclosed) have not been received from concerned Regional Labour Commissioner (C) despite several reminders due to which Grant-in-aid could not be released in time to the organisations and, resultantly the budget lapsed.

3. May I request you to kindly take up the matter with the concerned RLCs(C) personally and direct them to expedite the same in a time bound manner to enable us to process the cases of release of grant-in-aid to the organisations.

In case of new projects, an inspection of the organisation is conducted by the concerned Regional Labour Commissioner (C) to verify their credentials/financial standing, etc. and specific inspection report may be furnished in requisite proforma to this Ministry for further consideration of the project.

2. Science & Technology Entrepreneures' Park (STEP-HBTI), Kanpur, a Govt. of India organisation, sponsored by Ministry of Science & Technology has forwarded a project proposal for financial assistance under Grant-in-aid scheme of women labour for organising women labour awareness camps.
