ORDER:

In the Government Order first read above, a preliminary notification was issued to include the guidelines and welfare measures ordered by the High Court of Madras, dated 8.12.2000 on the employment of women in night shifts, amending the Tamil Nadu Factories Rules, 1950 so as to make the provisions as mandatory on the part of the employers and consequently objections and suggestions were also invited from the persons likely to be affected by such amendment.

- 2. The Director of Industrial Safety and Health in his letter second read above dated 17.3.2015 has stated that objections / suggestions were received from certain associations and they were diligently perused. The Government, after careful examination, have now decided to confirm the orders issued in the Preliminary notification with two more additional conditions.
- 3. The appended Notification will, accordingly, be published in the <u>Tamil Nadu</u> <u>Government Gazette</u> both in English and Tamil.
- 4. The Secretary to Government, Tamil Development and Information Department, Secretariat, Chennai-600 009 is requested to send the Tamil translation of the Notification to the Works Manager, Government Central Press, Chennai-600079.
- 5. The Works Manager, Government Central Press, Chennai-600 079 is requested to send 5 copies of the Tamil Nadu Government Gazette in which the

Notification is published for record to Government. He is also requested to send 5 copies of the Notification directly to the Director of Industrial Safety and Health, Chennai 600 014.
