| Desirable | (i) Three years' service in Home Guard or Civil Defence volunteers.<br><br>Note 1: The qualification regarding experience is relaxable at the discretion of the competent authority in the case of candidates belonging to the Schedule Castes or the Scheduled Tribes if at any stage of selection, the competent authority is of the opinion that the sufficient number of candidates with the requisite experience are not likely to be available to fill up the vacancy reserved for them.<br><br><b>For Ex-Servicemen:</b><br>The Armed Forces Personnel due to retire or who are to be transferred to reserve within a period of one year and having the requisite experience and qualifications prescribed shall also be considered. Such persons would be given deputation terms upto the date on which they are due for the release from the Armed Forces and therefore they may be continued on re-employment.<br><br>Note 1: The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation/ Department of the Central Government shall ordinarily not exceed four years.<br><br>Note 2: The maximum age limit by appointment by deputation/absorption shall not be exceeding fifty six years as on the closing date receipt of applications. |
