
CENTRAL GOVERNMENT INDUSTRIAL TRIBUNAL CUM LABOUR COURT, BENGALURU

Information under Section 4 of the RTI Act, 2005

Section 4(1) (b) (i): The particulars of its organisations, functions and duties - The subjects allotted to the Central Government Industrial Tribunal cum Labour Court, Bengaluru are to Adjudicate Industrial Disputes through Industrial Dispute Act, 1947 along with Industrial Tribunal (Procedure) Rules, 1949; Industrial Tribunal (Central Procedure) Rules, 1954 and Industrial Disputes (Central) Rules, 1957

Section 4(1) (b) (iii): The procedure followed in the decision making process, including channels of supervision and accountability:

The receipts received in the section are processed for necessary action as per the standard Manual of Office Procedure. Normally the channel of submission is as under:-

- (i) LDC
- (ii) UDC
- (iii) Secretary to Court
- (iv) Presiding Officer
- (v) Ministry of Labour and Employment

Section 4(1) (b) (iv): The norms set by it for the discharge of its functions: The Sections take prompt action, with utmost urgency on the reference received in the section, as per the time schedule and urgency of the matter.

Beside this, functions are also discharged according to various labour acts/laws/rules/regulations which are administered by the Main Secretariat, Ministry of Labour & Employment under Industrial Disputes Act, 1947 and Industrial Disputes (Central) Rules, 1957.

Sub-urb, Tumkur Road, Bengaluru – 560 022.

The Presiding Officer shall be the Appellate Authorities for the purpose of Section 19(1) of the Right to Information Act, 2005 with respect to CGIT-cum-Labour Court, Bengaluru.
