2. Accordingly, sealed quotations are invited for the disposal of the said vehicles on the terms and conditions mentioned below. Persons/firms, interested in purchasing the above mentioned vehicles, may submit their highest quotations in the enclosed proforma in a sealed cover addressed to the undersigned latest by 03.00 PM on or before **28<sup>th</sup> September, 2016** in the Tender Box kept at Reception Office of Ministry of Labour & Employment, Shram Shakti Bhawan, New Delhi. The quotations received in time will be opened at 04:00 PM on the same day i.e. on **28<sup>th</sup> September, 2016** in the Room No. 518, Shram Shakti Bhawan, Rafi Marg, New Delhi. The bidders or their representatives, not more than one for each quotation, may be present, if they so desire, at the time opening of Quotations. The cover should be prominently superscripted with the words "QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE".

3. The vehicles will be available for inspection between 03:00 PM. to 04:00 PM on 19<sup>th</sup> & 20<sup>th</sup> September, 2016.

4. The Auction of said vehicles will be governed by the following conditions:-
- I. The bidders are required to pay Earnest Money of Rs. 5,000/- (Rupees Five thousand Only) for each Staff Car and Rs.2,000/-(Rupees Two thousand Only) for three wheeler(Bajaj Auto).
  - II. Earnest Money is payable by means of Demand Draft drawn in favour of Pay & Accounts Officer (MS), Ministry of Labour and Employment, New Delhi (payment by cheque or cash shall not be accepted).
  - III. Quotations received without demand draft towards Earnest Money will not be considered and shall be rejected.

- IV. The successful bidder will be required to deposit the bid amount by means of Demand Draft drawn in favour of Pay & Accounts Officer (MS), Ministry of Labour and Employment, New Delhi within two working days of the acceptance of the bid.
- V. The Earnest Money of the successful bidder will be released only after the deposit of the bid amount. Earnest Money will not be adjusted as bid amount and will be forfeited, if he fails to honour the bid.
- VI. The delivery of the auctioned vehicles will be arranged only after the successful bidder submits documentary evidence in support of residential status (Voter Identity Card etc., in case of individual and Registration Certificate etc., in case of firms).
- VII. The auctioned vehicles will be removed by the successful bidder within 02 working days of depositing the bid amount, at their own expenses.
- VIII. The vehicles will be disposed off on "as is where basis" and no guarantee for its worthiness or quality will be given by the Ministry.
- IX. The successful bidder will also be responsible for getting the Registration Certificate of the Vehicle transferred in his name at his own cost expeditiously. The office will not be responsible for any lapse on his part in this regard.
- X. The bidders will not be allowed to withdraw their bids and if they do so their earnest money will be forfeited.
- XI. The undersigned reserves the right to accept or reject any/all of the quotations without assigning any reason.
