- (c) Attested copy of Community Status Certificate in the prescribed form in case of candidates belonging to SC/ST/OBC/EWS category.
- (d) Candidates seeking reservation benefits under SC/ST/OBC /PWD/EWS category must ensure that they are entitled to such reservation as per eligibility prescribed in the Notice and as per the instructions issued by Govt. of India. 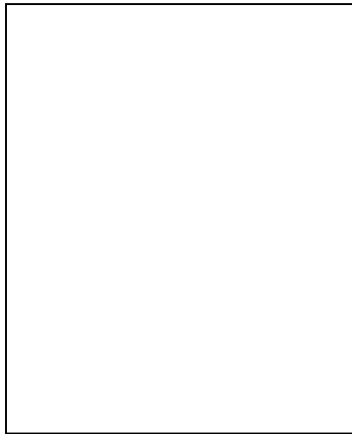
