- One post of Personal Assistant in Level 06 of Pay Matrix (as per recommendations of 7<sup>th</sup> CPC)
- (ii) As per the existing Recruitment Rules, the post may be filled up on deputation from the candidates:
- (a) Officers holding analogous posts on regular basis; or
- (b) With 10 (ten) years regular service in the Stenographer Grade in pay band –I Rs. 5,200-20200 with grade pay of Rs. 2,400/-.
- (c) Deputation (duty) Allowance shall be as per the guidelines issued by the DoPT No. 2/122/(B)/2008-Estt.(Pay II) dated 3<sup>rd</sup> September, 2008 (copy enclosed).
