CIRCULAR

Sub: Filling up of one post of Upper Division Clerk on Deputation basis in this National Industrial Tribunal/Central Government Industrial Tribunal cum Labour Court No.1, Mumbai-Regarding.

It is proposed to fill up one post on deputation basis in this NIT/CGIT cum Labour Court No.1, Mumbai on the following terms and condition.

- i) One post of Upper Division Clerk in the pay level-4 of Pay Matrix(as per recommendations of 7th CPC).
- ii) As per the existing Recruitment Rules, the post may be filled up on deputation from the candidates.
 - a) Officers holding analogous posts on regular basis in High Courts or from the subordinate courts; or
 - b) Officers holding analogous posts in the Central or State Governments and Central or State Public Sector Undertakings; or
 - c) Persons holding analogous post on regular basis in the parent Cadre or Department; or
 - d) Lower Division Clerks with eight years service in the grade rendered after appointment thereto on regular basis in Level 02 of the Pay Matrix (as per recommendation of 7th CPC)
- iii) Deputation(duty) Allowance shall be as per the guidelines issued by the DoPT NO. 2/22(B)/2008-Estt.(Pay-II) dated 3rd September 2008(Copy enclosed).
- iv) The Candidate selected will have the option to draw pay in the Pay Matrix as mentioned
- v) The period of deputation will ordinarily not exceed three years.
- vi) It is requested that the applications of interested, eligible and suitable candidates who can be spared for appointment may please be sent (in duplicate), after duly certifying the

details given by the candidate in the Bio-Data in the enclosed proforma along with their complete up to dated ACR's (attested photocopies of last five years) and vigilance clearance Certificate may be sent so as to reach the undersigned on the following address, latest within three months from the date of issued of this circular.
