CIRCULAR

Sub: Filling up of one post of Personal Assistant on Transfer on Deputation basis in the Central Government Industrial Tribunal-cum-Labour Court-2, Mumbai – reg.

It is proposed to fill up one post of Personal Assistant on deputation basis in Central Govt Industrial Tribunal-cum-Labour Court-2. Mumbai, initially for a period of one year, on the following terms and conditions:-

- 1 Personal Assistant
- One post of Personal Assistant in LEVEL 6 in the PAY MATRIX of 7th CPC [(Rs.9300 34800 with Grade pay Rs. 4200/- PB-II (pre-revised)],
- ii) As per the existing Recruitment Rules, the post may be filled up on deputation basis from the candidates:
 - a) (i) Holding analogous post on regular basis, or
 - (ii) With 10 years regular service in the Stenographer Grade in the pay band-1, Rs. 5,200-20,200 /- with grade pay of Rs. 2,400 /- (pre-revised), (Level 4 in the PAY MATRIX of 7th CPC) and;
- b) Possessing qualification as prescribed in Recruitment Rules for Direct Recruitment (i) 10 plus 2 from a recognized Board
 - (ii) Skill Test norms Dictation 10 minutes @ 100 w.p.m. Transcription: 40 Mins (English) 55 mins (Hindi) (on computer)
- Deputation (duty) Allowance shall be as per the guidelines issued by DOPT No 2/22(B) / 2008-Estt. (Pay II) dated 23rd September 2008.
- The candidate selected will have the option to draw pay as mentioned above (as per 7¹⁷ CPC) or draw pay in the current post plus Deputation allowance.
- Being differentials in basic pay the selected candidate will get enhanced empluments as per Pay Rules.

- 4. The period of deputation will ordinarily not exceed three years.
- 5.
