CIRCULAR

Sub: Engagement/ attachment for various positions under Special Operations Group (SOG) of eShram – regarding

The Ministry of Labour & Employment (MoLE) is implementing eShram project (National Database of Unorganised Workers) for the welfare of unorganised sector workers. eShram is a prestigious project for Ministry of Labour & Employment under which more than 29 crore unorganised workers have been registered so far. The eShram is also collating information/ data of more than 30 Social security/ welfare schemes. The data of these schemes help in identifying the left-out unorganised workers so that benefits of these schemes could be provided to the workers in targeted manner. Secondly, such data open up many avenues for the unorganised workers as well as participating schemes to have all related information from single platform.

2. In order to carry forward the above stated objectives, Ministry of Labour and Employment intends to form a Special Operations Group (SOG). This group will mainly function through three verticals: (i) Operations (ii) Data Analytics and (iii) Research & legal affairs. The operations vertical will be responsible for maintaining day-to-day operations of the eShram which include but not limited to, integrating eShram with various schemes, development of new services/ module on eShram, administration and HR, etc. The data analytics vertical will be handing complete data of eShram along with collating and analysing data of various schemes to bring out meaningful insights from the data. The Research and Legal Affairs vertical will be responsible for taking up various research projects under eShram and also, analysing and giving suggestions on various legal aspects of data handling, provisions on labour codes, etc.

3. The Ministry is therefore, looking for young and dynamic officers to become part of eShram-SOG on attachment/ loan basis under the above stated three verticals. The desirous officers having a drive for learning, innovation and research, particularly about data analytics, technology solutions to make better use of eShram portal/ data for welfare of unorganised workers of the country, must apply for SOG.

4. The officers having experience of 5 to 10 years are requested to apply through the link provided below latest by 30th September 2023 along with NOC from their respective departments:

6. No deputation allowance or any additional remuneration is admissible for the said positions in eShram-SOG. The officers will be attached with eShram SOG on loan/ attachment basis and will continue to draw pay and allowances from their existing office. The attachment will be initially for three years which can be extended up to 5 years based on the performance of the officer.
7. The selection of the eligible candidates will be based on assessment by a Selection Committee in the Ministry of Labour and Employment.
