CIRCULAR

Sub: Recruitment for two posts of Sub-Regional Employment Officer in the National Career Service Centre for SC/STs under the Directorate General of Employment, Ministry of Labour & Employment on deputation/absorption basis.

It is proposed to fill-up two posts of Sub-Regional Employment Officers (Group 'B'-Gazetted) in Level 7 of Pay Matrix (Revised) in the National Career Service Centre for SC/STs under the Directorate General of Employment, Ministry of Labour & Employment on Deputation/absorption basis from amongst the officers under the Central or State Governments and Union Territories:

- (a) i) holding analogous posts on regular basis in the parent cadre/department; or
ii) with three years' service in the grade rendered after appointment thereto on a regular basis in the pay scale of Rs.5500-175-9000 (Revised - Level 6 of Pay Matrix) or equivalent in the parent Cadre/Department and;

- (b) Possessing the educational qualification and experience mentioned below:-

ESSENTIAL

- (i) Master's Degree in Social Welfare or Labour Welfare or Social Work or Sociology or Economics or Statistics or Psychology or Commerce or Education of a recognized university or equivalent.
(ii) 3 years' experience in matters pertaining to Employment Exchange Policy and Procedure or Collection of Employment Market Information or Vocational Guidance, Employment Counseling and Placement of Personnel or Collection, Analysis and Interpretation of Socio-Economic Data.

DESIRABLE: Knowledge of Local Language (Hindi/Dogri);

2. The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organization/Deptt. of the Central Government shall ordinarily not exceed three years. The Departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation.

3. Presently, vacancies are at Jammu (J&K) and Mandi (H.P.). However, the persons selected can be posted at any of National Career Service Centres for SC/STs under the Directorate General of Employment with All India liability.

4. It is requested that the applications in the prescribed proforma (*which can be downloaded from the websites of the Ministry of Labour and Employment www.labour.nic.in/ and NCS portal <https://www.ncs.gov.in/>*) in respect of the officers who could be spared in the event of their selection may be forwarded to **Shri Sita Ram, Under Secretary to the Govt. 
5. The applications must be forwarded through proper channel and must accompany the following documents/information:

- (i) A certificate that no disciplinary proceedings/vigilance case is either pending or contemplated and a certificate to the effect that no major/minor penalties were imposed on him/them during the last 10 years.
- (ii) Complete and upto date APARs (in original/attested copies) from 2012-13 to 2016-17;
- (iii) Integrity Certificate; (iv) Cadre clearance certificate.

6. Applications received incomplete and/or after the last date and otherwise without the above documents/information will not be entertained. **The candidates, who apply for the post, will not be allowed to withdraw their candidature subsequently.**

7. Candidates strictly fulfilling the eligibility conditions and possessing the qualifications and experience as specified under para-1 and who are actually willing to join the post on their selection need only apply. The Curriculum Vitae (CV) duly supported by documents will be assessed by the Selection Committee while selecting candidates for appointment to posts on deputation basis.

8. The maximum age limit for appointment by transfer on deputation basis shall be not exceeding 56 years as on the closing date of receipt of application as per DoP&T O.M. No.AB-14017/48/97-Estt.(RR) dated 17/11/92 and No.AB-14017/2/97-Estt.(RR) dated 25/05/98.
