5. The promotion and payment of pay and allowances to Shri M. Dharmaraj shall be subject to the outcome of the W.P. No. 1508/2014 filed by Ministry of Labour& Employment before the Hon'ble High court of Hyderabad challenging the Order dated 21.06.2013 of the Hon'ble CAT, Hyderabad
