CIRCULAR

It is proposed to fill-up the following posts in the Directorate General of Employment, Ministry of Labour & Employment on deputation basis and Deputation/absorption basis:

- (iii) Three posts of Assistant Employment Officer (Group 'B'-Gazetted) in Level 6 (revised) – two posts on deputation basis and one post on Deputation/absorption basis – in the National Career Service Centre for SC/ST, Ranchi, Delhi and Chennai from amongst the officers under the Central and State Governments/Union Territories:
 - (a) i) holding analogous posts on regular basis in the parent cadre/department; or
 - ii) with three years' regular service in the grade rendered after appointment thereto on regular basis in the pay scale of Rs.5500-175-9000 (Revised-Level 6) or equivalent in the parent cadre/department; or

 - with eight years' regular service in the grade of Lower Division Clerk in Level-2 or equivalent;

2. The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organization/Deptt. of the Central Government shall ordinarily not exceed three years. The Departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation.

The posts of Sub-Regional Employment Officers/Officer on Special Duty/Assistant Employment Officer carries all India liability and persons selected can be posted at any of National Career Service Centres for SC/STs under the Directorate General of Employment.
