CIRCULAR

Sub: Filling up of two posts of Assistant Employment Officer and six posts of Upper Division Clerks in National Career Service Centres for SC/STs under the Directorate General of Employment, Ministry of Labour & Employment on deputation/absorption basis.

- (i) <u>Deputation/absorption basis:</u> Two posts of Assistant Employment Officer (Group 'B'-Gazetted) in Level 6 (Rs.35400-112400) One post each at Vishakhapatnam and Puducherry: From amongst the officers under the Central/State Governments/Union Territories:
- (a) i) holding analogous posts on regular basis in the parent cadre/department; or
 - ii) with three years' regular service in the grade rendered after appointment thereto in the Pay Band 2 (Rs.9300-34800) with Grade Pay Rs.4200 (revised) or equivalent;

 - <u>**DESIRABLE**</u>: (i) Knowledge of Local Language (Telugu/Tamil); (ii) Experience in matters pertaining to Employment Exchange Policy and Procedure or Collection of Employment Market Information or Vocational Guidance, Employment Counseling and Placement of Personnel or Collection, Analysis and Interpretation of Socio-Economic Data.
- (ii) On Deputation basis: Six posts of Upper Division Clerks in Level 4 (Rs.25500 81100) One post each at Kohima, Jabalpur, Jammu, Delhi, Vishakhapatnam and Bhubaneshwar: From amongst the officers under the Central Government:
 - i) holding analogous posts on regular basis in the parent cadre/department; or
 - ii) with eight years' regular service in the grade of Lower Division Clerk in Level-2 (Rs.19900-63200/-) or equivalent;
- 2. The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organization/Deptt. of the Central Government shall ordinarily not exceed three years. The Departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation.
