Sir / Madam,

I am directed to refer to this Ministry's letter of even number dated 14.03.2022 (copy enclosed) conveying the merger of National Child Labour Project (NCLP) Scheme with Samagra Shiksha Abhiyan (SSA) under Ministry of Education, Department of School Education & Literacy (DoSEL). While conveying the decision of merger, it was also requested to furnish the liability statement pertaining to pending liability claim of the districts in your State / UT, where NCLP Scheme was operational, with supporting documents by 31st March 2022.

- 2. In response, this Ministry received liability claims from some District Project Societies (DPSs), which have been examined in the Ministry. During examination, it was observed that most of the DPS had simply stated that certain amount is pending without indicating the particular year and without enclosing requisite documents like Utilization Certificate, audited statement, liability statement in the format prescribed by the Ministry, approval of the Ministry for operating the STC under NCLP, etc. Accordingly, this Ministry had requested such DPSs to furnish the requisite information to enable this Ministry to consider the claim of the pending liabilities.
- 3. In view of the above, it is requested that the liability claims, if any, pending for grants in respect of Districts in your State, and the information as sought by this Ministry while examining the proposal furnished by respective DPS may please be furnished along with all supporting documents etc by 30.11.2022 positively. If no information is furnished by 30.11.2022, it will be presumed that the concerned DPS has no pending liability / DPS has no information to furnish and the matter will be closed in the Ministry. Any Claim or information furnished in respect of NCLP Scheme, after 30.11.2022 will not be considered for processing in the Ministry.
