
CORRIGENDUM

CIRCULAR

Subject: Filling up of one post of Personal Assistant cum Stenographer on Deputation basis in the Central Government Industrial Tribunal cum Labour Court, Ahmedabad – regarding.

Applications are invited in the prescribed pro-forma (Annexure-1) from eligible candidates for appointment on transfer on deputation basis to the post of **Personal Assistant cum Stenographer** on Deputation basis in the office of Central Government Industrial Tribunal cum Labour Court, Ahmedabad.

2. The post belongs to Central Service (Group B, non-gazetted, Ministerial) in the pay scale of Level 6 as per 7th CPC and in the pre-revised pay scale of Rs.9300-34800 + 4200 Grade pay (6th CPC). Pay & allowances and other conditions of deputation shall be regulated as per the guidelines issued by the DoPT from time to time.

2. The period of deputation shall ordinarily be one year initially which may be extended up to three years subject to suitability or until the post is filled up by way of promotion on regular basis, whichever is earlier. However, the deputation could be cancelled prematurely, at the discretion of the Presiding Officer/HoD. The terms of deputation will be governed by the Government of India.

3. Eligibility criteria for transfer on deputation is as under:

a. Persons holding analogous post on regular basis as Personal Assistant cum Stenographer.

Or


b. With 10 years regular service in the grade in pay band-1 Rs.5200-20200/- with grade pay of Rs.2400/- (pre-revised), (Level 4 in the pay matrix of 7th CPC).
