3. The Officers are entitled for TTA/Joining Time as per relevant Rules. The officers mentioned at S.No 3 to 8 at para 2 will not be entitled for TTA/Joining Time etc., since their transfers are based on personal requests before completion of tenure of 4 years.

4. All concerned Organizations are requested to relieve the above mentioned Officers to enable them to join their place of new postings, immediately except S.No 2 and 3 of para 2 above. The Officers concerned are directed to submit their joining report to this Ministry through the respective Organizations of their postings at the earliest. The officers mentioned at para 2 of the order, except S.No 2 and 3, are directed to join the transferred post within a period of 30 days from the date of issue of the office order. In case any Officer does not join the promotional post within a period of 30 days, it will be presumed that he/she is not interested in availing of the promotion to JAG Grade and he/she will be debarred from promotion as per the relevant rules.
