The officer is directed to submit his joining report to this Ministry through the organisation of his posting, at the earliest. **In case he does not join the promotional post within a period of 30 days, it will be presumed that he is not interested in availing of the promotion to JTS Grade and he will be debarred from promotion as per the relevant Rules.**
