M Dharmraj before the Hon'ble CAT, Hyderabad.

- 6. All concerned Organizations are requested to relieve the Officers to enable them to join their place of new postings, immediately. The Officers concerned are directed to submit their joining report to this Ministry through the respective Organizations of their postings, at the earliest. In case any Officer does not join the promotional post within a period of 30 days, it will be presumed that he/she is not interested in availing of the promotion to STS Grade and he/she will be debarred for promotion for one year subsequent to the current vacancy year. The benefit of Non-Functional Up-gradation granted in the next higher grade will be withdrawn to such Officers who fail to join the promotional post as the benefit of NFU granted earlier is in lieu of regular promotion to the higher Grade.
- 7. The Officers are entitled for TTA/ Joining Time as per relevant Rules <u>except</u> Shri V. Muthu Manickam, who had sought transfer on personal/ medical grounds.
- 8. The promotion of S/Shri G.C. Majumdar and Kamaljeet Singh to STS Grade ordered vide this Ministry's Office Order No12/2013 dated 23/08/2013 and Office Order No.22/2013 dated 01/01/2014, respectively will be effective from the date of assumption of the charge of posts in STS Grade as indicated in para 5 above.
