Subject: Completion of pending APARs of JTS Officers of CLS – reg.


The undersigned is directed to refer to this Ministry's OM of even No. dated 18.12.2023 and reminder dated 29.02.2024 vide which the concerned organizations were requested to forward the pending APARs of JTS grade Officers of CLS to this Ministry latest by 10.03.2024. However, APARs of some of the JTS officers are still pending in the Ministry.

2. The concerned departments/ organizations/ establishments are once again requested to forward the APARs for the deficient period, completed in all respect (including Disclosure Certificate), in respect of the CLS officers (mentioned in the enclosed list) to this Ministry **latest by 03.05.2024**. If in any case the APARs could not be initiated due to any valid reasons, 'No initiation Certificate' may be furnished.

3. As per DoP&T's extant rules, the timeline for completion of APARs upto 2021-22 has already been elapsed on 31.12.2022. Therefore, 'No Report Certificate' wherever required and applicable as per the extant rules may be issued and submitted to the Ministry within the aforesaid time line.

4. The concerned officers are also requested to follow up the matter with their department/ organization/ establishment to ensure that completed APARs/ NRC/ NIC are sent to the Ministry within the stipulated time.
