- Gender Equality & Empowerment: Advancing gender-inclusive social protection systems to ensure equal access and economic independence.
- Data Collection & Reporting: Strengthening frameworks for accurate data collection, monitoring, and transparency.

Key Stakeholders

The seminar will feature participation from key ministries, including the Ministry of Finance, Ministry of External Affairs, NITI Aayog, Ministry of Health & Family Welfare and Ministry of Statistics & Programme Implementation (MoSPI). Industry partners such as CII, FICCI, ASSOCHAM, and NASSCOM will also share their views and insights. States/UT's will also be participating in the technical seminar.

Event Highlights

Day 1 will include an inaugural session, technical discussions on formalisation, flexible pathways to social security for vulnerable workers (difficult to cover groups), and targeted incentives for them.

Day 2 will focus on social protection delivery using digital solutions, communication strategies, gender equality and female empowerment through enhanced social protection coverage, strengthening data collection and reporting mechanism and medical care as social security.
