CIRCULAR

Subject: Filling up of one post of Personal Assistant on Deputation basis in the Central Government Industrial Tribunal cum Labour Court, Ahmedabad – regarding.

- 2. The post belongs to General Central Service (Group B, non-gazetted, Ministerial) in the pay scale of Level 6 (Rs.35400 112400/-) in the pay matrix as per 7th CPC. Pay & allowances and other conditions of deputation shall be regulated as per the guidelines issued by the DoPT from time to time.
- 2. The period of deputation shall ordinarily be one year initially which may be extended up to three years subject to suitability or until the post is filled by way of direct recruitment on regular basis, whichever is earlier. The terms of deputation and service conditions of employee may be altered and will be governed by the Government of India. The maximum age limit for appointment by deputation shall not be exceeding 56 years as on the closing date of receipt of application.

 - a. Persons holding analogous post on regular basis in Central Government and
 - Possessing the qualification and experience prescribed for direct recruitment rules.
