Eligibility	The applicant should be pursuing law [in the last two years of degree course] or Law Graduates or students pursing Post Graduation in Law or Research Scholars in Law or pursuing MBA / MSW / MSc / MA enrolled in recognized University/Institution within India or abroad.	
Duration	Duration of internship will be <u>from two to six months</u> at different points of time in the year.	
Stipend	The Interns will be paid stipend @ Rs. 8000/- per month for the period of internship on certification from the Officer, the Intern is attached to.	
Declaration of Secrecy	Interns will be required to furnish to the Ministry of Labour & Employment a declaration of secrecy before reporting for the internship.	
Logistic Support	Ministry of Labour & Employment shall provide them working space and computer with internet facility and other necessities as deemed fit by the concerned Heads.	
Placement	Placement of Interns (total 5 maximum) will be carried out with the approval of Secretary (L&E), after their engagement, keeping in view their suitability as well as requirement in concerned Wing/Division.	
Submission of Paper	The interns will be required to present to the Head of the Division a Report / Paper on the allotted subject at the end of the internship.
