TERMS & CONDITIONS FOR AWARDING CONTRACT FOR PEST CONTROL/TERMITE TREATMENT IN MINISTRY OF LABOUR & EMPLOYMENT.

Part-I GENERAL CONDITIONS

- (i) The period of contract will be for a period of one year. The contract can be terminated even before one year without assigning any reason thereof. No advance payment will be made in any case. Payment will be made on Quarterly basis on production of bills (in triplicate) along with satisfactory certificates from the concerned.
- (ii) This Ministry reserves the right to renew the contract, on the same terms, conditions and rates, for such period as it may deem necessary taking into account the services rendered during the contract period.
- (iii) The Pest Control treatment shall be given at least three services in a month in S.S. Bhawan and Jaisalmer House. All complaints shall be attended within two hours and routine check up will be done frequently.
 - a) The agency shall be responsible for any damage due to pests during the contract period.
 - b) The Ministry of Labour & Employment reserves the right to reject any or all the tenders without assigning any reasons thereof.
 - c) In all matters of dispute relating to this contract, the decision of this Ministry will be final and binding upon the firm.
