## OFFICE ORDER NO 18/2014

Consequent to exoneration of the charge (s) framed against Shri Vishal Kumar Khare, LEO(C), Hyderabad in the disciplinary case initiated by the Office of Chief Labour Commissioner (Central), vide its Order No. 4(2)/2005- Vig. dated 05.02.2014 and opening of Sealed Cover recommendations of the DPC held in the UPSC on 24.01.2013 wherein he was assessed as 'FIT' for promotion, the approval of the Competent Authority is granted for the notional promotion of Shri Vishal Kumar Khare to Junior Time Scale in the Pay Band-3, Corresponding Pay Scale Rs.15,600-39,100/- with Grade Pay of Rs. 5400/- against the panel Year 2012-13. The actual promotion will be effective from the date of assumption of charge of the promotional post.

4. Office of CLC(C), New Delhi and Office of Dy. CLC(C), Hyderabad are requested to relieve the Officer to enable him to join his place of new posting, immediately. The Officer is directed to submit his joining report to this Ministry through the respective Organization of his posting, at the earliest. In case he does not join the promotional post within a period of 30 days, it will be presumed that he is not interested in availing of the promotion to JTS Grade and he will be debarred from promotion as per the relevant Rules.
